## CAT COUNTRY 96 & 107.1'S "POCONO RACEWAY WEEKEND" CONTEST OFFICIAL RULES

The Station will conduct the CAT COUNTRY 96 & 107.1's "POCONO RACEWAY WEEKEND" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, age eighteen (18) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last seven (7) days or a prize valued at \$500 or more in the last seven (7) days, and whose immediate family members or household members have not won a prize from the Station in the last seven (7) days or a prize valued at \$500 or more in the seven (7) days. Void where prohibited by law. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Contest Period. The Contest entry period will begin at 3:00pmET on May 10, 2024 and will run through 11:59pmET on May 12, 2024 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.

## 2. How to Enter.

<u>Text</u>: Send a text message with the keyword SPEED spelled correctly to WCTO REQUEST LINE 610-720-9696 during the Contest Period. All entries must be received by 11:55pm ET on May 12, 2024 to be eligible for a chance to win a prize. Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider.

3. **Verification of Potential Winner.** THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. The potential winner must continue to comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. The potential winner may be notified by email and/or telephone call after the date of random drawing and/or winner determination.
