## CAT COUNTRY NETWORK "PAW PATROL LIVE" FACEBOOK CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station **WCTO-FM/WWYY-FM/WSJR-FM/WBHD-FM** [("Stations"), 2158 Avenue C, Suite 100, Bethlehem, PA 18017, during available business hours Monday through Friday, Station website www.catcountry96.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **Cat Country Network "PAW PATROL LIVE" Facebook Contest** (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. Include "Paw Patrol Live Facebook Contest" in the subject field. All entries must be received by 11:59am ET on May 2, 2025 to be eligible for the prize drawing. Limit one (1) entry per person per day, regardless of how many email addresses a person may possess and use. Multiple participants are not permitted to share the same email address. Any attempt by any participant to submit more than one (1) entry per day by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entry and the participant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. Station is not responsible for lost, late, incomplete, invalid, unintelligible, inappropriate or misdirected registrations, all of which will be disqualified.
